DAY ONE...

Day One is the only agency in Rhode Island that provides a full range of services for adult and child victims of sexual abuse. We provide treatment, intervention, education, advocacy, and prevention services to Rhode Islanders of all ages, from preschool children to elder adults and their families. Additionally, we advocate for public policy initiatives and systemic changes that positively impact Rhode Island families and communities.

Our full range of clinical services include:

- › Individual Therapy
- › Family Therapy
- › Group Therapy
- › Trauma Assessment Evaluations
- › Trauma-Processing Yoga Groups
- › Teen and Adult Survivor Groups
- › Non-Offending Caregiver Groups

RI CHILDREN'S ADVOCACY CENTER

Addressing the ever-present issue of childhood sexual abuse as well as the commercial sexual exploitation of children (CSEC), Day One's Children's Advocacy Center, with locations across the state, offers a child-centered environment to help abused children heal. ADVOCACY SERVICES

Talking about what has happened may be difficult for you. Day One's advocates are here to listen to you, validate your feelings, help you feel safe and give you resources and information about all of your options. Services include:

- ➔ **Multidisciplinary Teaming (MDT)** helps to ensure the medical, social services, and law enforcement response to child sex trafficking is victim-centered. The team develops a safety plan to ensure the stabilization and well-being of the child and to assist with the law enforcement investigation.
- ➔ **Survivor Mentor Program (SMP)** pairs former victims of human trafficking with youth who are at risk or confirmed to be commercially exploited.
- ➔ **Care Coordination** focuses specifically on responding to human trafficking victims and their unique support needs. Resources include crisis intervention; assessment of victims and their families; assistance with housing, transportation, education, financial needs; and more.
- ➔ **Law Enforcement Advocates (LEAs)** are based in police stations throughout Rhode Island. These trained Day One staff members follow up with every sexual assault and/or domestic violence victim that has reported an incident to police.
- ➔ **Office of Victim Services (OVS)** provides information and notification about offender custody status and changes through the RI-VINE program.
- ➔ **24-hour Helpline** advocates are available day or night to provide support, information, and accompaniment to sexual assault victims in the hospital, at the police station, or in court.

PREVENTION EDUCATION & PROFESSIONAL TRAINING

Our nationally recognized prevention education programs are age-appropriate and can be tailored to participants' needs. Covering topics including sexual harassment, bystander intervention and more, we provide multi-session programs for elementary school children, adolescents, college students, parents, and professionals.

Working with top researchers in Rhode Island, in partnership with the Centers for Disease Control and Prevention, Day One is one of only two agencies in the country to receive funding to evaluate the effectiveness of our high school program and one of four to receive funding to evaluate a social norms program for middle schools. This groundbreaking work will serve as a model for schools across the country.
